### **Chapeau**

1. The main outcome of the Summit of the Future should be to provide the United Nations Secretariat with sufficient political support to follow up on the Summit agreements and the Pact for the Future.
2. The Summit should provide the Secretariat with sufficient operational capacity to fulfill its task.
3. It is necessary to establish a United Nations Office of Strategic Foresight, Challenges and Existential Threats, at the level of the Secretary General, in connection with similar at the OOH of the system and member states.
4. Regarding one of the central topics and existential risks to be addressed during the Summit: the Artificial Intelligence, we want to point out our concern that in the regulations that are being prepared in different parts, for example in the EU, applications for weapons and military deployments are left out of the possibility of regulation. Which is one of the most dangerous areas. So, this is a main topic to be considered during the Summit and have to be part of the Pact for the Future. Moreover, it is imperative to consider a multilateral regulation, Artificial Intelligence has no borders, it is a global challenge.

### **Chapter I. Sustainable development and financing for development**

Reaffirm and reinforce the Addis Ababa Agreement and the Action Plan, for the financing of Development.

### **Chapter II. International peace and security**

1. Strengthen Peace Education and Future Literacy with massive programs in schools.
2. Strengthen the United Nations Peace University.

3. Reform the United Nations Security Council, expand its members in an inclusive and diverse manner, and incorporate new threats to peace and security within its competencies, such as Artificial Intelligence, Climate Change, Cybercrime, Biological and Nuclear Weapons, Science Diplomacy, Future of Work and Education, and Multilateral Management of Pandemics or Health Crises.

### Chapter III. Science, technology and innovation and digital cooperation

Create a system for monitoring and regulating technological development and its applications, generating binding standards based on respect for human rights, and encouraging the peaceful uses of scientific and technological developments, especially those that serve to solve regional and global challenges.

### Chapter IV. Youth and future generations

1. Incorporate young people into decision-making in the Multilateral System, by supporting their NGOs, their participation at different levels of the system.
2. Develop education for the future in the universities of the member states, with the support of UNESCO

### Chapter V. Transforming global governance.

1. Reform of the UN to provide it with greater powers and strengthen its agencies
2. Eliminate bureaucracy in the system, concentrating resources in strategic areas.
3. Strengthen the WHO.
4. Reform the WTO and resolve its paralysis in the dispute settlement system.
5. Strengthen the General Secretariat and its capacity to intervene in critical situations with sufficient financial, logistical and professional resources.
6. Reform the Security Council by incorporating new members, equitably and diversified, and expanding its powers to address new strategic and existential threats.
